INVITATION FOR EXPRESSION OF INTEREST FOR C.E.O. - SDCCB

Sundargarh District Central Cooperative Bank Ltd. invites Expression of Interest (EOI) in sealed cover from eligible candidates for appointment of Chief Executive Officer (Secretary) of the Bank. The applicants should be below 62 years of age as on 01.12.2018 and should have:

- (a) Minimum eight years work experience in the middle /senior LEVEL or above in the Banking Sector. Senior/middle level for the purpose shall be taken above the third level (scale/cadre) onwards i.e. excluding the first two levels (scale/cadre) in the officer cadre or as the highest two levels below the level of CEO.
- (b) The applicants must have any of the following educational qualification -
 - (i) Graduate with CAIIB/DBF/Diploma in Cooperative Business Management (DCBM) or Higher Diploma in Cooperative Management (HDCM) with similar course duration of OCBM (Condensed HDCM not eligible); or
 - (ii) Chattered / Cost Accountants; or
 - (iii) Post Graduate in any discipline

The appointment shall be for a period of three years subject to satisfactory annual review of performance and may be extended up to 65 years. The CEO is expected to lead the Bank and guide the affiliated LAMPCS and other cooperative societies down below to accomplish the overall objectives of business planning, credit disbursement, recovery along with membership drive etc. He shall be **responsible to the President and MC of SDCCB** and shall be required to work in close liaison with the DRCS, Lead Bank Manager, District Administration, OSCB, RCS(O), NABARD / RBI & Cooperation Department.

SALARY for the right candidate shall not be a constraint. Apart from free residential accommodation and vehicle for official use, the minimum total monthly emoluments for the post shall be above Rs. 1.25 lakh.
